Subject:- Annual General Transfer - 2016 in respect of Group 'B' Executive Officer(Superintendents & Inspectors) – reg.

Please refer to Para 5.1 of transfer guidelines dated 10.02.15 in which it is mentioned that efforts will be made to issue inter-Commissionerate transfer orders by 15th April every year.

2. In the above context, draft roster for posting and placement of the officers to the state of J&K was displayed on the official website of Central Excise Commissionerate, Chandigarh-I on 04.02.2016, inviting factual errors/discrepancies by 29.02.2016 positively. As no error/discrepancies have been pointed out even on date, the draft roster has been finalized as such and is hence re-displayed on the same website. This roster will form basis for AGT-2016 after deciding representations for relaxation if any, number of vacancies arising and to be filled up in J&K.

3. In terms of para 6.5 of the transfer policy, the lady officers, whose name appear in the said roster, were required to seek the exemption, if so desired, by 29.02.2015. While requests have been received from most of the lady officers requesting for exemption in terms of para 6.5 of the transfer policy, a few lady officers {para 4(ix) below} have not sought such exemption. It is thus presumed that they are willing to be posted to the state of J&K in terms of the roster.

4. Based on the information/data received through the Commissionerates, the following lists are being displayed on the official website of Central Excise Commissionerate, Chandigarh-I, to ensure complete transparency in the AGT process.

- i) Officers who will complete 4 years at a stretch in the present functional jurisdiction of Central Excise Commissionerates ;
- ii) Officers who will complete 4 years at a stretch in the present functional jurisdiction of Customs(P)Commissionerates, Amritsar/Customs Commissionerate, Ludhiana.
- iii) Officers who will complete 2 years at a stretch in the CCU.
- iv) Officers who will complete 2 years at a stretch in the Commissioners(Appeals)-I/II.
- v) Officers who have requested for inter Comm'ate transfers, prematurely or have sought retention beyond the normal period or have sought exemption (male officers) from posting to state of J&K.
- vi) Officers who will complete 6 years at a stretch in the state of J&K.
- vii) Officers who joined in the state of J&K prior to 01.04.2015 and will be completing/have completed one year and above but less than six years, at a stretch, in the state of J&K.
- viii) Officers who were posted in the Customs Charge of J&K state & completing one year in that charge at a stretch, in terms of the transfer guidelines.
- ix) Lady Officers who have requested/not requested for exemption from posting to state of J&K.

5. The request on medical ground/spouse grounds/children education ground (10+2) should be duly supported with the authenticated documents. The onus of supplying of these documents will be on the applicant, making such request. Therefore, if such documents (duly attested by the Commissionerate) have not already been supplied, the same should be submitted by 18.03.2016 positively.

6. It is also emphasized that the officers who are on CCL/any other kind of long leave should also make formal request giving their option/representation etc. No representation, on the ground that they were on leave during this period, will be entertained.

7. All the Commissioners are requested to ensure that this letter is displayed on the Notice boards of Commissionerate Hqrs office, Division and Range offices by 15.03.2016 positively.

8. Any factual errors in the lists, displayed on the official website of Central Excise Commissionerate, Chandigarh-I, can be pointed out either by Commissionerates or the concerned officer to CCU by 17.03.2016 directly through FAX. Any representation on this account received, thereafter, is likely to be ignored.
