**Subject:- Annual General Transfer - 2015 in respect of Group 'B' Executive Officer(Superintendents & Inspectors) – reg.**

Please refer to Para 5.1 of transfer guidelines dated 10.02.15 in which it is mentioned that efforts will be made to issue inter-Commissionerate transfer orders for 2015 by 15<sup>th</sup> April 2015.

2. In the above context, final roster for posting and placement of the officers to the state of J&K has already been displayed on the official website of Central Excise Commissionerate, Chandigarh-I.

3. In terms of para 6.5 of the transfer policy, the lady officers, whose name appear in the said roster, were required to seek the exemption, if so desired, by 20.03.2015. While requests have been received from most of the lady officers requesting for exemption in terms of para 6.5 of the transfer policy, a few lady officers {para 4(ix) below} have not sought such exemption. It is thus presumed that they are willing to be posted to the state of J&K in terms of the roster. However, to give them the benefit of lack of proper communication/late communication, it is requested that they should be advised to request for such exemption, if so desired by 09.04.2015 positively. In case, no such request is received by 5PM on 09.04.2015, it will be presumed that they are willing to be posted in the state of J&K in terms of their position in the Roster of J&K and no further request will be entertained.

4. With a view to ensure complete transparency, based on the information/data received from the Commissionerates, the following lists have been displayed on the official website of Central Excise Commissionerate, Chandigarh-I:

- i) Officers who have completed 4 years at a stretch in the present functional jurisdiction of Central Excise Commissionerates ;
- ii) Officers who have completed 4 years at a stretch in the present functional jurisdiction of Customs(P)Commissionerate., Amritsar. No such officer who have

- completed 4 years at a stretch in the present functional jurisdiction of Customs Commissionerate, Ludhiana, has been reported;
- iii) Officers who have completed 2 years at a stretch in the CCU;
  - iv) Officers who have completed 2 years at a stretch in the office of Commissioners(Appeals);
  - v) Officers who have requested for inter Comm'ate transfers, prematurely or have sought retention beyond the normal period or have sought exemption (male officers) from posting to state of J&K.
  - vi) Officers who have completed 6 years at a stretch in the state of J&K.
  - vii) Officers who have completed 2 years at a stretch in the state of J&K.
  - viii) Officers who have completed 1 year at a stretch in the state of J&K.
  - ix) Lady Officers who have requested/not requested for exemption from posting to state of J&K.

5. It is also seen that while other Commissionerates have forwarded the options/requests, received from the officers for a particular Station/Comm'ate, no such lists have been forwarded by Central Excise Commissionerate, Chandigarh-I. It is, therefore, requested that all the officers in Central Excise Commissionerate, Chandigarh-I who wish to give options/requests (either for station/Comm'ate after completion of tenure or premature transfer/retention/exemption), should give their representations/requests by 09.04.2015 through their Commissionerates with a FAX copy directly to CCU by 09.04.2015 positively. No requests, will be entertained after this date. Even in case of other Commissionerates, the last date for receiving of requests relating to transfer/retention/exemption has been extended up to 09.04.2015 i.e. such requests should be in office of the Chief Commissioner by 5PM on 09.04.2015. No requests thereafter will be entertained.

6. The request on medical ground/spouse grounds/children education ground should be duly supported with the authenticated documents. The onus of supplying of these documents will be on the applicant, making such request.

7. It is also emphasized that the officers who are on CCL/any other kind of long leave should also make formal request giving their option/representation etc. No representation, on the ground that they were on leave during this period, will be entertained.

8. All the Commissioners are requested to ensure that this letter is displayed on the Notice board of Commissionerate Hqrs office, Division and Range offices by evening of 06.04.2015 positively.

9. Any factual errors in the lists, displayed on the official website of Central Excise Commissionerate, Chandigarh-I, can be pointed out either by Commissionerates or the concerned officer to CCU by 5PM on 09.04.2015 directly through FAX.

10. As the target date of issuing the ICT orders is April 15, it is in the interest of the officers to ensure that their requests reach this office latest by 09.04.2015.
