

4. As it was an election cum general body meeting, the following points were also discussed in the meeting and these were resolved as given under:-

(i) Promotion of TA to STA (Pre Cadre)/EA.

The Members raised the point for getting promotion from TA to STA (Pre Cadre) on the basis of Vadodara and Cochin Zone as their batch-mate of CGLE 2012 got promotion to the grade of STA/EA before completion of 3 years.

The house was apprised that there are only 03 vacancies of ST category in the grade of STA (pre-cadre) are available. The matter shall be taken up with Administration to fill up these vacancies according to Rules.

(ii) Notional benefit on delayed promotion from the grade of TA to STA for RY 2014-15.

The Members raised the point regarding their notional promotion for the RY 2014-15 w.e.f. 01.04.2014 instead of 04.04.2014 due to which they had to suffer a whole year for their promotion in next hierarchy.

The house was apprised that this matter alongwith all the other matters related to late promotion shall be taken up with Administration for grant of notional benefit or to take up the matter with Board office.

(iii) Notional benefit from LDC to TA.

The Members raised the point regarding their notional promotion from the grade of LDC to the grade of TA.

Action shall be taken as per reply of Point II above.

(iv) Parity with CBDT in respect of Pay, Post & RRs.

(v) Notification/Publication of RRs of AO.

(vi) Seniority list of AOs publication/finalization.

(vii) DPC for the promotion to the grade of CAO.

The Members raised the points regarding the parity with their counter parts in CBDT w.r.t Pay structure, Cadre / Post and Recruitment Rules. Pending notification / publication of RRs for AO, Delay in finalization of Seniority list of AOs and delay in holding DPC for the vacant posts of CAO.

The house was apprised by Sh. Ram Lalit, now the President of National Association, that being the policy matters, these issues have already been taken up with Board office / DGHRD and again reiterated on 13.04.2017 to the Chairperson in the meeting held with her.

(viii) Compulsory membership of CGHS

The Members raised the issue of facing the problem in getting their medical experienced reimbursed by deptt. under CS(MA) Rules 1944. Now we are forced to avail CGHS facilities where only one CGHS dispensary is available with over burdened beneficiaries.

(ix) In-house GST training to Ministerial Officers

(x) Provision of Room for Association activities CCS(RSA) Rules 1993


The Chairman apprised to the house that the matter shall be taken up with the Administration on the above points.

The meeting ended with a vote of thanks to the chair.
