Board vide letter dated 03.08.2017 has directed to implement of CAT, Chandigarh Bench order dated 03.08.2012 in OA No. 338/PB/2012 filed by Sh. Balwinder Singh Matharoo and others in respect of all concerned (petitioners and non-petitioners) under Central Board of Excise & Customs.

2. As per Board directions and in terms of Hon'ble CAT Bench order dated 03.08.2012 in OA No. 338/PB/2012, the officers who were transferred on ICT and were in the zone of

consideration during 1996-97, has been placed in the draft gradation list after counting their past service rendered in parent Comm'ate. The claim of the applicants was based on the orders dated 26.08.1997 in OA No. 651/1997 of the Hon'ble Principal Bench, CAT, New Delhi in the case of I.C. Joshi & others which was affirmed in judicial review by the Hon'ble Delhi High Court in order dated 18.02.2009. The department filed SLP against the order dated 18.02.2009 of the Hon'ble Delhi High Court and the same was dismissed by the Hon'ble Apex Court vide order dated 12.12.2011.

3. The draft gradation list, so prepared, is being uploaded on the official website of Central GST Commissionerate, Chandigarh (www.cexchd1.gov.in) for inviting objection, if any, for giving one week's time. After examining the objections/error, received if any, the same will be finalized and sent to CCU for convention Review DPC.
