Sub: Proposed Directorate General of GST Intelligence - Posting of Senior Intelligence Officers (SIOs) / Intelligence Officers (IOs) on local transfer basis in the Zonal Units at Delhi, Gurugram, Jaipur, Ludhiana and Chandigarh from amongst officers of the corresponding Zone - reg.

As you are aware in the GST environment the reorganized field formations and Directorates are to be effective from 01.06.2017 and the extant Delhi Zonal Unit of DGCEI shall be carved into 5 Zonal Units at Delhi, Gurugram, Jaipur, Ludhiana and Chandigarh, each headed by Pr.Addl./Addl. DG having separate compliment of officers and staff. Each of these set ups shall be an expansion over present levels. Gurugram shall also be the headquarter of the organization's North Zone.

2. The above reorganization involves allocation of human resources from local Zone/Commissionerates to the DGCEI which is being renamed as Directorate General of Goods & Service Tax Intelligence and is being strengthened and expanded to be the important wing of the Government in its fight against tax evasion and black money.

3. In the light of this, there shall be vacancies in the grade of SIOs/IOs to be filled (effective from 01.06.2017) at above mentioned locations by officers from corresponding Central Excise /Service Tax Zones. Hence, it is requested to please communicate separate lists of suitable/eligible and willing officers clear from vigilance angle for being selected as SIOs and IOs, along with brief bio-data, history of posting and APAR/ACR gradings. The list may please be of officers with requisite experience. For ease of coordination, the Delhi Zone may send its list to Delhi Zonal Unit, the Chandigarh Zone to Ludhiana Regional Unit and the Jaipur Zone to Jaipur Regional Unit. In view of the short time available, it is requested to please send the lists by 15.05.2017 so that we can make a quick response for further necessary action.
