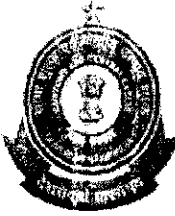

Bench/2013/5139 dated 20.11.2015 wherein your goodself was requested to provide, as an interim measures, two rooms with some basic facilities like internet/fax/printer etc. for the necessary working of the officers of ARs (copy of the letter is enclosed).
