Ten Thousand only) in form of Demand Draft payable to the Chief Accounts Officer, Central Excise & Service Tax Commissionerate, Chandigarh-I along with bids. In case of unsuccessful bidders the draft of Earnest money will be returned after short listing the successful bidder(s). In respect of successful bidder(s) the draft of Earnest money will be returned after satisfactory supply/installation of items. Interested parties are also required to submit a declaration certifying that the items for which rates have been quoted are as per or of higher specifications as mentioned in the tender document.
4. The rates quoted should be net (including all taxes). Discounts/free services / offers quoted in the quotation will not be considered. Preference will be given to bidders who have authorisation from OEM.
5. The payment shall be made after satisfactory installation of equipment.
