The Audit Circles will be headed by Deputy or Assistant Commissioner and will comprise of Audit Groups having Superintendents and Inspectors. The Audit Groups will conduct coordinated and integrated audit covering Central Excise and Service Tax for the registered assesseees having common Permanent Account Number (PAN). OSPCA would also be carried out by the designated Audit Circle/Group in an integrated manner.

The Trade Notice shall come into force with effect from 15th October, 2014.

All the trade associations/Chambers of Commerce and members of RAC/PGRC are requested to publicize the contents of this Trade Notice amongst their members/constituents for information and necessary action.
